STATEMENT OF AGREEMENT & TERMS

The undersigned "Purchaser" agrees that all purchases made by Purchaser from **R & R Provision Co.** of Easton, PA are subject to the following terms & conditions:

- 1. All amounts due **R & R Provision Co.** are payable in accordance with the payment terms granted by **R & R Provision Co.**'s credit department. If any amount due is not paid within said period a delinquency charge of 18% on an annual basis or the highest interest rate permitted by law, whichever is less, may be added to the sum due. Furthermore, Purchaser agrees that **R & R Provision Co.** may suspend all deliveries and sales to Purchaser if any sum due hereunder is delinquent.
- 2. All sums owing by Purchaser shall be deemed to have become immediately due and payable if: (a.) Purchaser defaults in any obligation to **R & R Provision Co.**; (b.) A petition under any chapter of the Bankruptcy Act, as amended, or the appointment of a receiver of any part of the Purchaser's property is filed against the Purchaser, and not dismissed within thirty days; (c.) Purchaser makes a general assignment for the benefit of creditors, suspend business or commit any act amounting to a business failure; or (d.) Any judgment is entered against the Purchaser, or any assets of Purchaser are levied or otherwise subject to any involuntary lien which includes, without limitation, any judgment or tax lien.
- 3. Purchaser shall notify **R & R Provision Co.** by certified mail of any change in ownership. The Purchaser further agrees to be liable for all purchases should the undersigned fail to comply with said notification.
- 4. Purchaser does hereby empower any attorney of any court of record within the United States or elsewhere to appear for Purchaser and after one or more declarations filed, confess judgement against Purchaser as of any terms for the total outstanding balance with cost of attorney's fees, collection fees, and court costs incurred by **R & R Provision Co.** for collection and release of all errors, and without stay of execution and inquisition and extension upon any levy on real estate is hereby waived and condemnation agreed to and the exemption of personal property from lien and sales of any execution hereon, if also hereby expressly waived and no benefit of exemption be claimed under and by virtue of any exemption law now in force or which may be hereafter passed.
- 5. Purchaser authorizes investigation of all credit references, business and / or personal contained on this application. This Agreement and your relationship with **R & R Provision Co.** shall be governed by the domestic internal laws of the Commonwealth of Pennsylvania. Purchaser hereby submits to the jurisdiction of the Court of Common Pleas of Northampton County, Pennsylvania and the United States District Court for the Eastern District of Pennsylvania, and hereby agrees that the venue of said Courts shall be proper in all respects. **R & R Provision Co.** shall be entitled to any and all out of pocket costs, including, without limitation, attorneys' fees and court costs incurred to collect any sums due hereunder. EACH PARTY HEREBY EXPRESSLY AND IRREVOCABLY WAIVES ANY RIGHT TO A TRIAL BY JURY AND ACKNOWLEDGES THAT THE FOREGOING WAIVER IS KNOWING AND VOLUNTARY.

In consideration of **R & R Provision Co.**'s agreement to provide restaurant supplies, food stuffs, and any other items to the Purchaser's business on such credit or cash terms as **R & R Provision Co.** may extend from time to time. I (we) do hereby guarantee individually and jointly, personally and unconditionally the payment by said business of any past due amount (including dishonored checks) with **R & R Provision Co.**
